- The Kruiise of Klamath will hold our Show ‘n Shine event on Main Street between 3rd and 11th from 7am to 6pm on Saturday.
- We will then transition to our evening cruise on Main and Klamath between 3rd and 12th from 6:00pm to 8:00pm.
- Food vendors may elect to operate during all, or a portion, of the time between 7am to 8pm on Saturday but preference will given to those vendors able to provide service starting at 7am.
- Food vendors will be located at various predetermined locations along Main Street. Locations will be selected with consideration for areas along Main Street that do not already have existing restaurants.
- Space is limited and the Kruiise of Klamath reserves the right to select which vendors are granted space with a *preference for food vendors that set up for breakfast.*
- Vendors will be sent information regarding their location, access and setup instructions two weeks prior to the event.
- Canopies are allowed as long as they are properly weighted to prevent them from moving.
- No alcohol is permitted during the event.
- Access to electricity and/ or water will not be available – vendors must be totally self-sufficient.

****Food Vendor Klamath County Licensing Guidelines:**

- All food vendors must be licensed with Klamath County unless specifically exempted by Klamath County. Written proof of the exemption must accompany vendor registration.
- If a food vendor is already licensed in Klamath County, no additional fee is required by Klamath County but the food vendor must notify Klamath County of a temporary change in location.
- If a food vendor is already licensed in another county in the State of Oregon, they must complete an application form from Klamath County and pay a fee to Klamath County.
